

QUICK QUACK SHINE LIKE A KING **SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of California who live within 75 miles of the Golden 1 Arena located at 500 David J Stern Walk, Sacramento, California, who are 18 years of age or older at the time of entry. You need not be present to win.
